- 1. CALL TO ORDER The regular meeting of the Yale Water & Sewage Trust Authority was called to order at 6:29 p.m. by Chairman Clara Welch.

- 6. AWARDING OF CONTRACTS
 - a. Consideration, discussion and action to award a contract for the financing of a natural gas transmission line to the City of Yale. Mr. Porter recused himself from the meeting leaving the room. Mr. Kelly initiated a conference call with Mr. McMillian and Mr. Brownlee. Mr. Kelly recommended American Heritage Bank as the lowest bid with a rate of 2.55%. There was discussion on a 10-yer note with an earlier payoff. Richard Adsit made the motion to approve financing with American Heritage Bank for the construction of a natural gas transmission line to the City of Yale in the amount of not more than \$300,000 with a 7-year term and 2.55% rate. Jason Brown seconded the motion which passed as follows: Yea: Brown, Adsit, Welch Abstain: Porter.

 - b. Consideration, discussion and action to award a contract for the construction of a natural gas transmission line to the City of Yale. Mr. Kelly read the 8 bids that were received. Brian Porter, Jr. stated there needed to be a change order for seeding/sodding to 13,500 feet from 17,000 per Mr. Brownlee. Richard Adsit made the motion that the Yale Water & Sewage Trust Authority enter into a contract for construction of a natural gas pipeline with Orr Construction, Inc. at the bid quantity prices stated in the bid of Orr Construction dated February 4, 2021 in a maximum amount of \$253,203.00 and made contingent upon Orr Construction satisfying and meeting all of the requirements and specifications required of the successful bidder in the bid notices and specifications for such gas pipeline project.

- d. Consideration, discussion and action to employ an inspector for inspection of the natural gas pipeline to be constructed by the City of Yale. Mr. Kelly recommended to hire Craig Brownlee as the inspector for the natural gas pipeline project at the rate of \$500 per day of inspection. Brian Porter, Jr. made the motion to hire Mr. Brownlee at the rate of \$500 per day of inspection services on the natural gas pipeline project. Jason Brown seconded the motion which passed as follows: Yea: Brown, Porter, Adsit, Welch Nay: None.

 - a. Report from Lone Chimney Rep: The lake is full and they are pumping water.
