1. **CALL TO ORDER** – The special meeting of the Yale City Commission was called to order at 6:30 p.m. by Mayor Richard Adsit.
2. **ROLL CALL** – Those present were Mike Strader, Jason Brown, Larry Brown, Paul Rosenquist and Richard Adsit.
3. **ORDINANCES**
  - a. **Consideration, discussion and action on Ordinance No. 388 “AN ORDINANCE AMENDING SECTION 4-17 OF THE YALE CITY CODE TO PROVIDE FOR MOBILE HOME SITE REQUIREMENTS, AMENDING SECTION 4-19 OF THE YALE CITY CODE TO PROVIDE FOR INDIVIDUAL MOBILE HOME PERMITS, AMENDING SECTION 4-20 OF CHAPTER 4 OF THE YALE CITY CODE TO PROVIDE FOR MOBILE HOME OCCUPANCY PERMITS AND DECLARING AN EMERGENCY.”** – Mr. McMillian stated he was asked to prepare this Ordinance by Mayor Adsit, as the Mayor felt the Ordinance that was in place wasn't right and not due to any certain circumstances. Mr. Jason Brown stated he had a problem with the change due to the temper tantrum that was thrown at the last meeting, and that an adult discussion was needed.   - b. **Consideration and discussion on the proposed 2021-22 fiscal year municipal budget.** – Staff discussed proposed budget as presented.
